RESOLUTION 24 – 003

A resolution expressing the property taxation policy of USD 501, Topeka Public Schools with respect to exceeding the Revenue Neutral Tax Rate for financing the annual budget for 2023-2024.

Whereas, 2022 HB 2239 amending K.S.A 79-2988, provides that a levy of property taxes to finance the 2023-2024 budget of USD 501 exceeds the Revenue Neutral Tax Rate to finance the 2023-2024 budget of USD 501, be authorized by a resolution.

Whereas the USD 501 Revenue Neutral Rate, as calculated by the Shawnee County Clerk, for the 2023-2024 budget is 42.21 mills

Whereas USD 501 intends to exceed the Revenue Neutral Rate with the proposed mill levy rate of 44.542 mills

NOW, THEREFORE, BE IT RESOLVED by USD 501 that the 2023-2024 budget with a levy of property taxes exceeding the Revenue Neutral Tax Rates calculated for 2023-2024, as adjusted pursuant to 2022 HB 2239 amending K.S.A 79-2988 is hereby adopted.
